This proposal has been presented during the LRPCE on February 12, 2025 and approved by March 14.

However, representatives of the MDs and SDs (eventually the Undisctricted clubs) could also be part of the Working Group in the future.

The EF Peace Working Group, in addition to the "Peace Ambassador" award, should continue to:

- study and promote common and shared initiatives aimed at spreading the culture of peace.
- coordinate and facilitate initiatives proposed by various EF MDs and Lions districts for peace and understanding between peoples
- carries out his activity under the supervision of the LRPCE and presents a report periodically on his work to LRPCE and to the Europa forum.

A draft proposal for the regulation of the "Peace Ambassador" award has been prepared which will be reviewed and implemented by the working group in the first meeting.

The first step is to transform the attached draft proposal of the regulation of the "Peace Ambassador award" into a final proposal that can be approved by LRPCE.

In this proposed meeting we will be able to get to know each other and give ourselves time to evaluate the draft regulation to be discussed in a subsequent meeting.

Please can we meet on June 29th at 09:30 to get to know each other and make our comments on the regulation?

A resolution will need to be presented at the next EF in Dublin if it will be possible.
